Frequently Asked Questions

1. What is the background and mission of Coastal Family Vacation Foundation (CFVF)?

A cancer diagnosis affects not only the patient, but the entire family unit. CFVF was founded after seeing many of our family members and neighbors battling the disease. We saw the trauma and stress that families go through emotionally, physically, and financially. As South Carolina residents, we wanted to reach out across the state and help others find a way to quell their anxiety and fears, take a respite from worry and make memories that will last a lifetime.

CFVF has one mission: To provide all-inclusive beachside respite vacations to South Carolina residents actively undergoing cancer treatments. CFVF is a 501(c)(3) nonprofit that strives to provide a safe and restorative space for families to heal and reconnect so they can return home renewed and ready to face another day on the road to recovery.

2. How are nominees selected for a respite vacation?

Patients must be nominated by a member of their oncology team to be considered for the program. Through their frequent and extensive contact, the patient's medical team is best suited to make an assessment of whether or not a patient is a good candidate for a respite vacation. CFVF relies on the input and expertise from the oncology team as they have the most up-to-date information and know which patients can most benefit from the program.

3. What is included in the CFVF Vacation Award Program?

Our goal is to provide families with everything they need to take a hassle-free vacation. CFVF provides lodging for up to 7 nights, a stipend for gas and groceries, a family beachside photo shoot, and a local amenity or excursion. Examples are a golf cart or bicycle rental, surf lessons or beach chair and umbrella rentals. When required, we also provide rental equipment such as hospital beds or cribs.

It is our sincere desire that, by taking care of the physical needs of a family, they can focus their time and attention on reconnecting with each other, unplugging from uncertainty, and shedding anxiety and weariness that pervades their daily routine. We hope families can utilize this time to relax, build sandcastles, search for shark's teeth, and embrace all of the healing elements available in a peaceful coastal environment.

4. What is the process for donating time at my beach property?

We would be honored to accept your gift of discounted time in your beach property. We know that donated stays will be the conduit by which we maximize the number of vacations we award each year. We ask that all homeowners interested in offering time at their property complete the attached questionnaire. This will help us to know the size of the family that your home will accommodate, the dates you are interested in donating, etc. We will then reach out to you via telephone and email to confirm the dates you have set aside for a family. Our general liability policy provides coverage during the time the family is staying in your home. And, as such, CFVF is required to provide some form of consideration in exchange for accepting time at your property.

Once a family is selected, we will provide you with a copy of the vacation agreement that the patient has signed on behalf of their family. We will work out the check in and out details, entry requirements and departure protocols with you well ahead of their arrival date. If your vacation home is managed by a property management company, we are happy to work with you or your property manager.

We will follow up with you 10 - 14 days prior to the vacation date to confirm any last-minute details. Although it is unfortunate, sometimes due to changes in treatment and surgery schedules, a vacation must be rescheduled. We make every effort to place a different family in your home when this occurs, however, sometimes cancellations cannot be avoided. We will make every effort to advise you as soon as we are aware that the vacation scheduled for your property cannot take place as planned.

CFVF understands that we form a partnership when you decide to donate your home. Your decision affirms that we are working toward the same goal of showing kindness and compassion to our neighbors. You can call us anytime if you have questions about this process.

5. How much can I deduct on my taxes if I donate time in my property?

Please consult your tax advisor for details on deductions regarding the operation of your specific property. In general, actual expenses incurred for the donation, such as linens, cleaning, or utilities, are typically deductible.

6. Speaking of cleaning and linens, who does this?

The homeowner is generally responsible for cleaning before and after the family arrives as well as the linens. If you do not wish to provide linens, please let us know in advance and provide contact details for a local linen company so we can make the necessary arrangements.
